• **Remark:**

1. Above for reference only,
2. For those require Alpha hydroxy acid test or anti-dandruff agent test, 2 or 3 samples shall be added respectively and each test charges RMB900 ;
3. Single test sample shall be over 30g/30ml; Otherwise, shall increase the number of sample for test;
4. For those products with PH \ll 3.5, human test shall be additionally made and expense will be charged extra;
5. In the event of sun screener over 0.5%, test fee shall be quoted individually.
6. Test fee for risk ingredients :
 - (1) dioxane、methanol、phenol (RMB600)
 - (2) asbestos (RMB1000)
