Remark:

1. Once a product has more than two individual packages or separated parts (*like blusher,eyes shadow, powder pact*) with deferent ingredient composition, such packages or parts shall be tested respectively

- 2. Those with alcohol \geq 75% (w/w) needn't take microbes test.
- 3. Those without antibacterial agent in the formula(*like physical hair removal, pure herbal hair dye*) shall take microbes test.



- 4. Those with the content of alcohol and isopropanol $\ge 10\%$ (w/w) shall take methonal test.
- 5. Besides sun screen products, those with sunscreen ≥0.5% (w/w) (*excluding titanium dioxide and zinc oxide*) shall take sunscreen test, experiment of derma feedback to anomalism and skin phototoxicity test, which charge RMB6000 in total.
- 6. Those who claims to have α -hydroxy acid or α -hydroxy over $\geq 3\%$ (w/w) in the formula shall take α -hydroxy acid and PH test which costs RMB900 in total.
- 7. Those products which claims to fight acne, acarid shall take antibiotcs and metronidazole test which costs RMB1000.
- 8、Those products which claims to have anti-dangdruff effect shall take anti-dangdruff agent test which costs RMB900.
- 9、 Those with talc in the formula shall take asbestos test which costs RMB 1000.
- 10、 Hair dye product which has two or more formulations shall take hygiene and chemical test accordingly against each formula.
- 11、 Every single sample for test shall have its net weight over 25g, otherwise, more samples shall be supplemented.
